- ✓ Injuried player in case injuried player, who can't to play would like to be on the bench, he has been written in schoresheet, and he has to be dessed on official team uniform (training suite)
- ✓ president or manager of club hasn't rights to sit on the bench
- ✓ coaches line is mandatory in the sport hall;
- ✓ Home team is responsible of delivering of results to responsible person of its home federation (LVF I. Brokāne +37126191094, EVF- T.Pürn) and delivering of schoreshhet to federation;
- ✓ About sanctions of team members after each game 1st referee of the game informs home federation
