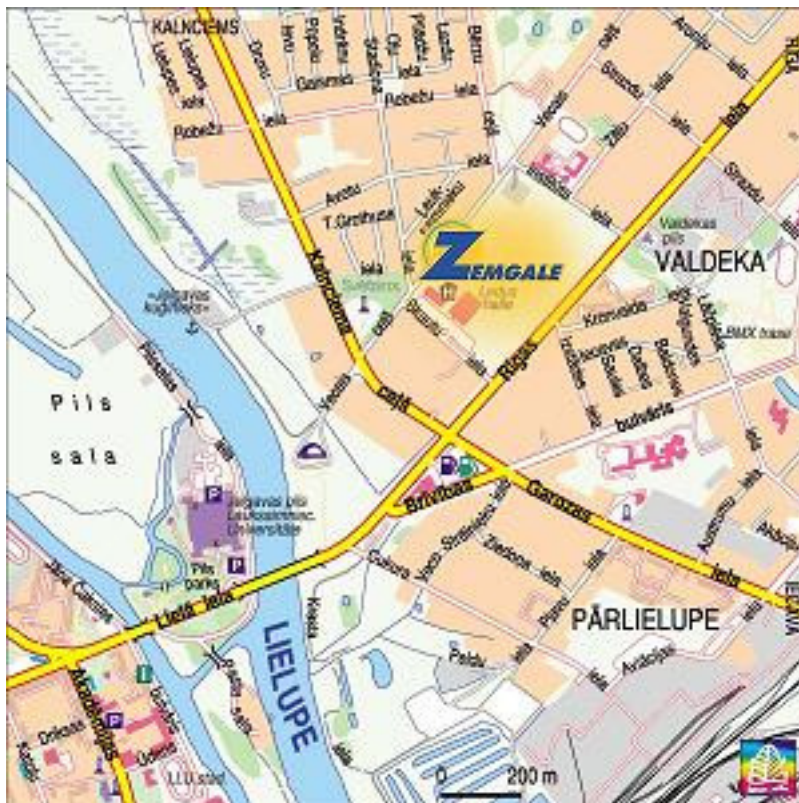

6. TRANSPORTATION

Each participating team is responsible to organize and pay travel to Jelgava and local transport in Jelgava.

7. REGULATIONS

7.1. Introduction

National Federations of the Baltic countries aims to make the competitions for women teams more active for spectators, media and sponsors in order to guarantee the competition a higher status that will also result in a benefit to the main performers.

7.2.Competitions System and programm

No main tournament will be played. Six teams will qualify to the Final Six Tournament, where the games will be played as follows:

I Day (Friday) – Quarterfinals:

18:00 Match No 1 LTU 2 vs EST 2

20:00 Match No 2 LTU 1 vs LAT 2

II Day (Saturday) – Semifinals and game for 5th place

12:00 Match No 3 (for 5th place) Loser of Match No 1 vs Loser of Match No 2
 14:00 Match No 4 Winner Match No 1 vs LAT 1
 16:00 Match No 5 Winner Match No 2 vs EST 1

III Day (Sunday) – Finals

11:00 Match No 6 (for 3rd place) - Loser of Match No 4 vs Loser of Match No 5
 13:00 Match No 7 (for 1st place) – Winner of Match No 4 vs Winner of Match No 5

Match for the 3rd place has to be played before the match of the 1st place.

Points scoring system

Win with result 3:1 or 3:0 - gives 3 points
 Win with result 3:2 - gives 2 points
 Lose with 2:3 - gives 1 point
 Lose with 0:3 or 1:3 - gives 0 point

7.3.Starting time of the matches

Starting time of the matches are between 12:00 (on Sundays 11:00) till 20:00.

7.4. Balls

The official ball of the BWVL tournament is **MIKASA MVA-200 (new)**. Hosting club provide at least 12 MIKASA MVA-200 balls for the warming-up for the match.

7.5. Uniforms

All participating teams has to present to representative of hosting club **two** samples of uniforms. It is not allowed to play in the same colour of uniform for both teams, in this case that is responsibility of hosting club.

7.6. Referees

Referees (1st and 2nd Referee, scorer, 2 linejudges-for the Final matches) are nominated by Refereeing commission of the respective federation of the hosting club; other staff (ball retrievers, floor moppers, announcer) have nominated by hosting club. Visiting clubs can to bring own referee, nominated by respective NF Referee Commission, in this case concerned federation in the written form has to inform hosting federation at least 10 days before the Final tournament, i.e. till **12 January 2010** at latest. In this case visiting club is responsible for covering of all expenses of nominated referee (per diem, transportation, lodging, meals).

7.7. Registration fee and financial items

Registration of the teams is going through the respective National federation with the form **WBL-02 – deadline is 15 January 2010**.

Registration fee is 150 EUR (remark „Women Baltic League”), which by clubs have to be paid till **20 January 2010**.

All travel (to and back to the competitions place as well as during the competitions) and lodging costs will be bear by participating teams by themselves. Hosting club of the Final tournament in case of request of visiting teams will assist to arrange possible the cheapest accomodation for official delegation max 17 persons. Hosting club of the Final Six tournament is responsible for all organizing expenses, including sports hall, equipment, local referees and all concerned staff.

7.8. Awarding

Participation of the first three teams in the Awarding ceremony is mandatory.

7.9. Miscelaneous

Administration and awarding of these competitions will be arranged in close co-operation of all concerned federations – LAT VF, EST VF, LIT VF.

The highest authority of WVBL is Jury, the members of Jury are Secretary Generals of federations of participating countries.

Visiting team before the match has to present to the 1st referee of the match collective, issued and confirmed by respective National Federation.

Hosting club has to arrange training possibilities for visiting teams according the teams request and following to the FIVB Regulations, water for the players during the trainings and game as well.

Participating of the first three teams in the Awarding ceremony is mandatory.

All matters don't announced in these Regulations could be the object of the discussions, but final decision is made by Jury.
